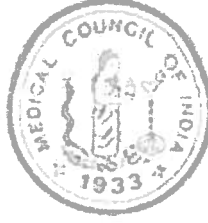

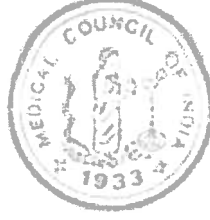

I am to state that the General Body of this Council at its meeting held on 30/03/2016 considered the Compliance Verification Assessment (04/03/2016) along with the Council Assessor's Report (May, 2015) and compliance dated 21/09/2015 submitted by the college authorities on the physical and other teaching facilities available at Konaseema Institute of Medical Sciences & Research Foundation, Amalapuram for the award of MD(General Medicine) qualification for 05 seats under Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.
