No. 9812, 9814, 9879 of 2020 challenging the action of colleges not permitting the candidates to report and pay fee are also pending before Hon'ble High Court of Andhra Pradesh.

That I am herewith paying the half yearly instalment of tuition fee including other fees fixed under G. O. Ms. No. 56, Dt. 29.05.2020 and I undertake to pay the remaining Fee for second half of first academic year, 2<sup>nd</sup> year and 3<sup>rd</sup> year as well. I further undertake, without prejudice to my rights, to pay the tuition fee including other fees payable pursuant to the decision of the Hon'ble High Court in above batch of Writ petitions or by the Hon'ble Supreme court of India or order of Government or any authority concerned.

I further declare that I am fully conversant with the rules and regulations of KONASEEMA INSTITUTE OF MEDICAL SCIENCES & RESEARCH FOUNDATION, AMALAPURAM on matter of recovery of pending tuition fee and other fee (not exceeding Rs. 45,000/- for three years subjected to the decision of the Court of Law) from its students and the Principal of the institution may take any such legal action deemed fit to recover the dues from us.
