That I am aware of the fact that AP Private Dental Colleges Managements Association, Vijayawada have filed Writ Petitions bearing nos: 32975, 33162 & 35090 of 2022 before the Hon'ble High Court of A.P., on behalf of Private Dental Colleges in the State of AP, challenging the various aspects of fee fixation by APHER&MC / Government of Andhra Pradesh. The Hon'ble High Court of A.P., in its Orders Dt. 21/07/2023 stated "this court deems it appropriate to enhance the existing fee of the academic year 2022-23 at the rate of 10% for the academic year 2023-24. The Hon'ble High Court also directed the respondent No. 1 to go ahead with the counselling notification in respect of BDS admissions and further directed the respondents to notify the enhanced fee for the academic year 2023-24 duly enhancing 10% as a tentative fee i.e. Rs. _____ till the fixation of final fee as per the procedure under the provisions of Act 20 of 2019 and rules made there under. The enhancement of fee is also made applicable for the academic years 2024-25 and 2025-26

That, I am herewith paying the tuition fee of Rs. _____ (in Words) per annum fixed for Competent Authority quota/ Management Quota as per the above orders of the Hon'ble High Court of A.P.
